Considering all these aspects, we do not feel that it is necessary to reduce the fee of the college for 2013-14 and 2014-15 by 50% on the ground that it has given false information. It is necessary to note that for those years whenever DTE stopped admissions, the college approached the High Court and the High Court either by interim order or even final order directed admissions in the college. All these relate back to the date of deficiencies found in the college as if these deficiencies were not relevant. Hence we dismiss both the Complaints.

Item No. 5: To discuss and decide the letter dt. 29/08/2015 received from Directorate, Technical Education, Mumbai regarding Institutes not fulfill the norms as per given by AICTE.

Considered the letter dated 29/08/2015 received from Directorate, Technical Education, Maharashtra State, Mumbai pointing out certain deficiencies. The deficiency regarding teaching staff would affect to the effect the salaries. This will be considered for approval of fees for AY 2016-17 as the report is of July 2015. The Directorate, Technical Education Department shall be required to convey the deficiencies found to AICTE for taking action. The representative of Directorate, Technical Education shall take note of these proceedings.

Item No. 6: To discuss and decide the letter dt. 30/11/2015 received from Dr. D.Y. Patil Technical Campus, Lehegaon, Pune regarding to collect Stationery and Other fees from the students. (Ref: Minutes 9/4/2015 Item No. 4).
