

SC/ST CELL

An SC/ST Cell in engineering colleges acts as a dedicated, statutory body (as per AICTE/UGC guidelines and the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989) to ensure the welfare, protection, and academic support of students and staff from the Scheduled Caste and Scheduled Tribe communities. It handles grievances, manages scholarship information, and promotes equal opportunities to prevent discrimination.

Key Responsibilities & Functions

- **Grievance Redressal:** The cell addresses complaints of discrimination, academic, or administrative issues in a confidential, timely manner.
- **Policy Implementation:** Ensures strict implementation of reservation policies and guidelines from the Central Government, MHRD, and AICTE.
- **Scholarships & Support:** Disseminates information regarding government scholarships, fellowships, and financial support, such as Post-Metric Scholarships.
- **Development Activities:** Conducts remedial coaching, personality development programs, and workshops to improve employability.
- **Counselling:** Provides counselling to students to help them overcome social or personal problems and assists in academic progression.

Structure & Operations

- **Composition:** Usually headed by a senior faculty member (Convener/Liaison Officer) and includes members from various departments, often chaired by the Principal.
- **Meetings:** Meets at least twice a year to review issues and initiatives.

Establishment of committee for SC/ST


